
#### **ANNOUNCEMENTS**

### **Clay Armbrister Transition**

- We were all very proud to hear that Executive Vice President Clarence Armbrister accepted the position of Chief of Staff for Mayor-elect Michael Nutter.
- Clay has contributed so much to Temple University over the past five years. On behalf of the entire Temple community, I would like to formally recognize his outstanding service and commitment to Temple.
- While we will miss Clay very much, all of Philadelphia will benefit from the success of the Nutter administration under his steady hand.
- Though Clay will continue his relationship with Temple until he officially begins his new role in January, he has concluded his day-to-day work so that he can focus his efforts on Philadelphia and Mayor-elect Nutter's administration.
- I have consulted with leaders in Clay's portfolio and from across the university to develop an interim plan for leadership of these divisions. The talent pool in the office of the Executive Vice President is very deep, and we will leverage our internal strengths while we evaluate a permanent structure.
- I have made additional assignments to several of the vice presidents, and have in some instances realigned reporting responsibilities to other divisions. I also will be meeting monthly with an expanded leadership team to include division heads in each of the areas in operations.
- As we learn more about the effectiveness of this transition organization, I will develop plans for a permanent structure.
- While Clay's loss will be felt, I am confident that we will be able to continue to perform at a high level.

#### Report on Fire at Penrose Hall

- On Sunday December 2, fire was discovered in Penrose Hall on the Tyler School of Art campus in Elkins Park.
- Flames broke out in Room 203 of Penrose Hall, a print shop used by undergraduate art students.
- Damage was contained to this area. No injuries were reported and, with the exception of the affected room, all Tyler opened for classes the following day.
- The cause is under investigation.
- The incident was managed professionally by members of Temple Police, facilities, operations and Tyler faculty and administration, who helped assure the safety of Temple students and faculty and minimize losses.



#### 1. Introduction

- I stated in my investiture address that Temple has a responsibility to internationalize teaching, discovery, and engagement or risk being left behind in a rapidly changing world.
- I strongly believe Temple University is poised for success as a global university.
- Though there are many areas that will require additional focus and investment, we are building from a position of strength.
- A recent trip to Asia's most influential regions reinforced Temple's existing presence and revealed an incredible wealth of opportunities for expansion of our international education initiatives.



## 2. The Temple Delegation

- In a series of meetings, events and ceremonies, members of the Temple delegation cultivated relationships with government and educational leaders that will benefit the university for decades to come.
- Throughout nearly two weeks in China, Taiwan and Japan, we had unprecedented access to leaders in government and education.
- Fellow trustee Solomon Luo represented the Board with integrity as a key member of the Temple delegation. I was delighted for the opportunity to spend time with Sol and his wife, Wendy, throughout the entire trip.
- I believe this is a pivotal moment for Temple. The choices we make today will determine our level of influence in the global economy.
- We began our trip in Beijing. China has the world's most rapidly growing economy, and Temple is playing a role in the landmark cultural change now underway.


## 3. Distinguished History in China

- Temple University's relationships with the people and institutions of China date to the late 1970s.
- Temple was one of the first American institutions of higher education to host scholars and researchers following the establishment of U.S.-Sino relations.
- The first graduate of Temple University from modern China was Vice Premier Deng Xiaoping, who was awarded an honorary doctorate in 1979.
- This fact provides Temple with tremendous credibility among the Chinese people.



#### 4. Early Academic Partnerships with China

- In 1980, a delegation led by Temple President Marvin Wachman visited China and established academic partnerships with Chinese universities that continue today.
- Temple owes its early presence in China to Professor Emeritus of Biology Dr. Man-Chiang Niu, a respected Chinese scientist who was personal friends with Premier Deng.
- I was honored that Dr. Niu, at 95 years, could join us at our alumni reception in Beijing. Sadly, Dr. Niu passed away just days later at his home in Beijing. His funeral was attended by a host of scientific and state leaders including Chinese President Hu Jintao.
- We are grateful for Dr. Niu's influence in establishing Temple's historic ties to China.




#### 5. Temple-Tsinghua Law Program

- Nearly four decades later, Temple's strong ties to the nation continue.
- While in Beijing, we participated in graduation ceremonies for the largest class in the history of Temple's groundbreaking master of law program at Tsinghua University.
- Established in 1999 with leadership and support from the US Department of State and Senator Arlen Specter, the program is the first foreign law degree granting program approved by the Chinese Ministry of Education.
- The LL.M. program is one of several Temple programs having a profound effect on the development of rule of law in China by educating lawyers, judges and other legal professionals in the principles of Western law.
- Since 1999, more than 700 legal professionals have been educated through one of Temple's Rule of Law initiatives.



## 6. Important Relationships in Beijing


- Thanks to the success of its rule of law programs, Temple University is respected at the highest levels of the Chinese government.
- Temple's cooperative program with the National Judicial College of China is one example of these important relations. The program provides legal education for Chinese judges. To date, 163 have attended the three-month program.
- Our signing ceremony with the Chief Justice of the Supreme People's Court of China was featured prominently on the front page of the People's Court Daily, one of China's most influential and authoritative newspapers, with a circulation of more than 3 million. A translation of the article is included on page 1 of the report of media coverage distributed to you today.
- We were also received by the Chinese Minister of Education, who expressed his pleasure with the depth of Temple's existing relationships in China. He is interested in exploring other ways we can work together.
- And we renewed Temple's relationship with the State Administration of Foreign Experts Affairs, the central government agency responsible for academic exchange programs and other initiatives that bring foreign experts to China.
- My service as Chair of the Commission on International Programs for the National Association of State Universities and Land-Grant Colleges has the potential to place Temple at the forefront in developing relations between Chinese and American institutions. I took the opportunity to invite each of these leaders to Temple to promote collaboration between US and Chinese educational systems.



#### 7. Temple Alumni in China

- More than 1,000 Temple alumni and graduates of Temple-related programs live in China.
- Our significant presence was evident at the first all-Temple reunion held in China. Almost 300 graduates and their guests attended the event the first reunion in China to include alumni from all of Temple's Schools and Colleges.
- Building on the strength of our alumni, Temple has the potential to play a leading role in the development of Chinese legal, economic and healthcare systems.




#### 8. A Major Presence in Taiwan

- Taiwan presents another opportunity for Temple's dramatic international growth, and we have taken our first steps toward a major presence there.
- Here is how Temple University was represented on Taiwanese television.

That amazing news story was broadcast on one of Taiwan's largest television stations. For those of you whose Mandarin is a little rusty, a translation is included on page 11 of the media report.




#### 9. Taiwan Signing Ceremony

- The story describes the ceremony in Tapei during which we formalized partnerships with six of Taiwan's leading universities.
- Taiwan's Vice President Annette Lu was a special guest, and Taiwan's minister of education, Cheng-Sheng Tu, presided.
- As you can see in the media report, the event garnered significant media attention, with articles in all of Taiwan's major news outlets.
- These cooperative 3+2 arrangements allow highly qualified Taiwanese students from National Taiwan Normal University, National Cheng Kung University, National Taiwan University of Science and Technology, National Sun Yat-Sen University, Tunghai University and Chung Yuan Christian University to receive a bachelor's degree from their home university and a master's degree from Temple.
- This is a model for educational exchange that can be replicated throughout Asia and around the world.




#### 10. New Friends and Partnerships

- Other important engagements in Taiwan included a dinner with the Chancellor and other academic leaders from Northern National Taiwan University System, a tour of National Taiwan Cheng Kung University, and a meeting with the dean of the College of Medicine at National Taiwan University.
- I also had the opportunity to meet with Tseng-Chang Su, former Premier of Taiwan and a current candidate for Vice President. His daughter, Chiao-Ning, is now a student at Temple.
- These successes in Taiwan would not be possible without the leadership of Hai-Lung Dai, dean of Temple's College of Science and Technology. Dean Dai, who was born and raised in Taiwan, has generously shared his deep connections within his native country and throughout Asia to benefit Temple.
- Earlier this week Dean Dai reported that he is helping Temple secure 3+2 agreements with two additional Taiwanese institutions, Tamkang University and Fujen Catholic University. He also has been discussing similar programs at the University of Science and Technology of China and at two highly regarded universities in Korea.
- With Dean Dai's guidance, Temple is becoming one of America's most recognized universities for Asian students seeking to pursue advanced studies.
- I am incredibly grateful for his dedication in helping to secure Temple's future as a global institution.



#### 11. Taiwan Alumni Gathering

- We hosted another exciting alumni event in Taiwan, attended by more than 100 Temple graduates.
- The gathering of mostly young alumni was remarkable for the energy that filled the room. Our graduates were thrilled to reconnect with Temple and one another, and were genuinely excited about Temple's potential in Taiwan.



# 12. Temple University Japan 25<sup>th</sup> Anniversary

- The last leg of our journey took us to Temple University Japan.
- The anniversary event hosted by U.S. Ambassador Thomas Schieffer at his private residence in Tokyo was a celebration of Temple University Japan's success.
- TUJ is an example of how international relationships can pay dividends for many years.
- When Temple University Japan was established 25 years ago, the idea of introducing Americanstyle education in Japan was considered radical. But the university's unwavering support of this bold endeavor has paid off.
- Today, TUJ enrolls more than 3000 students in 11 majors and sends students from Japan to study here at Temple's Main Campus. More than 2700 Temple alumni live in Japan.
- The event reinforced TUJ's important position in Japanese education and the local and international communities in Japan.
