### **Guest Speaker**

### a. <u>Temple Student Government</u>

\*\*Aron Cowen, Class of 2017 College of Science & Technology President, Temple Student Government

Chairman O'Connor, President Englert, and distinguished members of the Board of Trustees, I am deeply honored to represent the Temple student body today.

Temple students are enjoying a well-earned Spring Break, after a productive start to the spring semester. Notes have been taken, student organization meetings attended, midterms passed. On warm days, the bell tower has been packed with students studying, relaxing, and even dancing. Campus has hummed with activity, with the beautiful sound of learning.

And campus has been busy in other ways. Just as the seasons are changing (current weather notwithstanding), so too is the very look of our university. New buildings are sprouting to life, and old ones renovated and repurposed. Students are excited to take advantage of these new facilities to further their studies, and as a soon-to-be-alumnus, I cannot wait to see what Temple looks like in a few years.

Our student-athletes are also excelling, as they always do, in and outside of the classroom. Just yesterday, our Women's Basketball Team, led by the AAC's coach of the year, Tonya Cardoza, was invited to the NCAA tournament for the first time in years. And this year set an all-time record for our Division I athletes' Graduation Success Rate, another in a series of academic achievements that speaks to the emphasis, from Athletic Director Pat Kraft down, that has been put on the well-roundedness of our student athletes.

In the tradition of Russell Conwell himself, Temple students are giving back. On MLK Day, several hundred students, faculty, and staff fanned out to a variety of locations to paint, clean, and otherwise lend a hand. Tax season is upon us, and for the tenth year in a row, accounting students from the Fox School of Business are providing free income tax assistance to members of the surrounding community.

Mr. Chairman, with recent events at Middlebury College in mind, I want to take a minute to reiterate the importance of academic freedom and discourse. Universities are sacred places where, more than any other place, the market of ideas should flourish. But over the past few years, there has been a disturbing increase in speakers shouted down, uninvited, or otherwise silenced; from Condoleezza Rice to Sa'ed Atshan, this intolerance to differing views has no partisan affiliation, but it is growing and it is wrong.

The very concept of banning speech, outside of that which by the Brandeis test is a clear and imminent threat, is anathema to what universities should stand for. Shutting down ideas that are disagreeable serves no constructive purpose, helps nobody.

It encourages separation, cloistering, and the formation of groupthink-dominated bubbles. It prevents discourse through which falsehoods can be brought into the light and corrected: one cannot convince someone to see a different perspective if you refuse to hear and address their views. It robs students of the opportunity to develop skills such as critical analysis, which the process of reconciling differing viewpoints naturally teaches. The idea of banning speech is easily turned against those who would advocate for it, centralizing the power to decide what is acceptable in the hands of very few, whose current good intentions are no guarantee against future change. And lastly, to think that we have a monopoly on what is right, that what is currently viewed as 'correct' is and will always be correct, is the height of hubris. Every generation looks back at something a previous generation took as common sense and asks how they could be so foolish. Inevitably, the same will be said about us. Inevitably, we will turn out

to have been wrong about something. It is a dangerous path to ban the discussion of ideas we find wrong, for we may find ourselves having shut down what ends up being right in the end.

Universities exist as a place where new ideas can gestate. They exist as a place to be a bit uncomfortable, to wrestle with differing ideas, to challenge your worldview. That has long been one of the hallmarks of academia, stretching back to Socrates challenging the leaders of Athens.

And Temple University too has a long and proud tradition in this regard, whether it was supporting the rights of our professors to criticize the Vietnam war in the 60s, to supporting their right to challenge conventional wisdom in a variety of ways to this day. I am grateful for this past, for this history, and I urge that we not just continue but reinforce this fine tradition. We owe it to our students, but more than that, we as an institution of higher education owe it to ourselves to remain a place to challenge the conventional, to question the accepted, and pioneer the new.

Temple students are ready to grapple with tough questions, our faculty to challenge and inspire them, and our wonderful administrators and staff to support them in their intellectual journey; as always, it is going to be an excellent, productive spring.
